1. The Earnest money of Rs.40,000/-(Forty Thousand) in form FDR duly pledged in name of "Principal, LLRM Medical College, Meerut." is necessary to be attached with the tender form, Otherwise tender form will be rejected.
2. All the tenderers should submit the Income Tax/VAT clearance along with tender form. In the absence of these documents, the tender shall not be accepted.
3. In case the tender is given in the name of any firm, the registration certificates of the firm should invariably be attached with the tender form, without it will be rejected.
4. Tenderer should not have any objection if the tender is decided on basis of picked items. If any contractor refuses to accept it, his earnest money/security money shall be forfeited to the government.
5. In case of the detailed terms and conditions of the tender notice, tender form and the agreement bond, the contractor should be noted carefully before filling and submitting the tender form.
6. Tenderer should not quote the rates of controlled rates item with the conditions that the permit to be provided by the hospital. the tender shall not be accepted.
7. All the tenders must submit the sample of 100gm each items in shite glass bottle of side mouth duly sealed or signed.
